

#### **OVERVIEW**

In 2015, the state proposed the development of 8 Transition Support Teams (TST)

- 254 counties of Texas
- 39 LIDDAs and community waiver providers within a designated region



# TST TEAM

#### TST must include:

- Licensed health-related professionals with expertise working with individuals with IDD such as:
  - Social Worker
  - Physician
  - Physician's Assistant
  - Nurse Practitioner
  - Registered Nurse
  - Psychiatrist
  - Psychologist
  - Behavior Specialist

# PURPOSE OF TST

Assist LIDDAS, and providers of HCS, TxHmL, CLASS and DBMD programs serving individuals with IDD who are:

At risk of being admitted to institutional setting

or

Transitioning from institutional setting back into the community

\* Institutional Setting = nursing facility (NF), state hospitals (SH), state supported living center (SSLC), or jails

## WHO TST SUPPORTS

#### Provide Medical, Behavioral, and Psychiatric Support to

- Local Intellectual and Developmental Disability Authorities (LIDDAs)
- Home and Community-based Services (HCS) program providers
- Texas Home Living (TxHmL) program providers
- Community Living Assistance Support Services (CLASS)
- Deaf Blind with Multiple Disabilities (DBMD)
- LMHA/LBHA services
- And any other provider and professionals who are working with people with IDD

#### EDUCATIONAL ACTIVITIES

- Educational activities are centered around Medical, Behavioral, and Psychiatric topics
  - Topics are often requested by community members
- Offered to private provider agencies, LIDDAs, and others who help persons with ID/DD

# EDUCATIONAL ACTIVITIES OR TECHNICAL ASSISTANCE PROCESS

- Contact appropriate Transition Support Team with request
- Will receive response within 3 business days with acknowledgment of receipt and if required, request for more information
- Will provide response to technical assistance within 3 business days unless otherwise noted
- Will schedule training to fit needs of your audience

#### CASE REVIEWS

#### Regular case review sessions

- 3 day response with acknowledgment of receipt and if required, request for more documentation
- Conclude with a written report and follow-up instructions provided within 2 work weeks


## CASE REVIEW REFERRAL PROCESS

- PASRR Habilitation Coordinator from designated LIDDA will contact appropriate Transition Support Team to notify of recommendation for Community Transition
- Will receive response within 3 business days with acknowledgment of receipt
- Designated LIDDA's PASRR Habilitation Coordinator will present the individual to TST's multidisciplinary team for recommendations
- Conclude with a written report and follow-up instructions provided within 2 work weeks
- Additional meeting attendance and/or NF visit is at the discretion of the TST

#### TEAMWORK

- Teams work together to assist when a person is transitioning to an area that is outside of their region.
- We share training and educational opportunities throughout the state.
